

Chinchilla Polocrosse Club Camping Agreement

BY SIGNING THIS HIRE AGREEMENT, THE HIRER ACKNOWLEDGES THAT THEY HAVE READ AND UNDERSTAND AND AGREE TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS OF THE HIRE AGREEMENT.

THIS IS AN IMPORTANT DOCUMENT.

PLEASE READ CAREFULLY BEFORE YOU SIGN. YOU MAY WANT TO SEEK INDEPENDENT ADVICE.

1. AGREEMENT TO HIRE

- a. The Chinchilla Polocrosse Club permits the Hirer use of the Site subject to:
 - i. the terms expressly set out in this agreement.
 - ii. all applicable rule, by-laws, and regulations of the Club.

2. HIRE FEE

- a. The Hirer must pay to the Club the Hire Fee in the following manner, time being of the essence:
 - i. payment to be made at time of booking.
 - ii. refunds for cancellations will not be accepted after Thursday 9th February 2023

3. THE HIRER'S OBLIGATIONS

- a. The Hirer shall not remove any items such as fixtures and fittings or structures from the Site.
- b. The Hirer shall keep the site in good repair, order, and clean condition at all times during the Hire Period to the satisfaction of the Club.
- c. At the termination or expiry of this Hire Agreement the Hirer must, at the Hirer's cost, leave the Site in clean and tidy condition that existed prior to the hire of the Site.
- d. The Hirer must not cause or contribute to any damage to the Site or the grounds generally. Such damage must immediately be made good at the Hirer's cost, to the satisfaction of the Club.
- e. The Hirer shall not allow disconnection of or disruption to any utility or other services or alteration of our disruption to existing improvements with respect to site, without the Clubs prior approval.
- f. The Hirer must use any property, goods, materials, services, or information provided by the Club at or on the Site:
 - i. At its own risk

- ii. Using reasonable care; and
- iii. In accordance with the Club instructions (if provided).
- g. The Hirer is responsible for the safety and security of all people who attend the Site and the grounds during the Hire Period. The Hirer is solely responsible for the implementation of any safety and security measures. The Club will have no responsibility for safety and security during the Hire Period.
- h. The Club may at any time enter the Site during the Hire Period and observe the use of the Site and any activities conducted at the Site. The Club takes no responsibility for the safety, approval or supervision of any activity by doing so.
- i. The Hirer must not engage in any activity at the site during the Hire Period which may bring the reputation of the Club into disrepute.
- j. The Hirer must not engage in any activity at the Site during the Hire Period which may be or become offensive, dangerous give rise to undue noise or smell or which in the opinion of the Club may cause annoyance, offence or cause danger to the public.
- k. The Hirer must vacate the Site by the hire end time. If the Hirer fails to do so, the Club may seek costs against the Hirer or impose any other penalties it sees fit.
- I. If the Hirer does not comply with the above clauses during the Hire Period, then the Club may immediately and without notice:
 - i. Take possession of the Site
 - ii. Remove any goods from the Site. Any goods removed in this was which remain in the Club's possession after a period of thirty days will be treated as abandoned and such goods will become the property of the Club.

4. TERMINATION

- a. The Club may for any reason whatsoever immediately terminate or suspend the operation of this Hire Agreement by notice to Hirer at any time.
- b. In the event for such termination the Hirer will cease occupation of the Site immediately upon being so directed by the Club.

5. PETS

- a. Pets are not permitted in the amenities block.
- b. Dogs are not permitted as per Polocrosse Australia rules.

6. FIRES

a. Campfires must be contained within fire pits.

7. CAMPING NOTICES

a. Our grounds are NOT a commercial caravan park.

- b. Powered sites will require at least 1 x 30-meter extension lead and in some cases 2. Please be aware that power will be supplied via mains supply & generator and not all power points are 15AMP. There could be occasional interruptions to power during peak periods.
- c. Watering points are not available at each site, however there are a number of hose taps located throughout the camping area for your use.
- d. We have adequate toilet and shower facilities (4 separate amenity blocks)
- e. The camping will be managed by volunteers from the Chinchilla Polocrosse Club, no bullying or abuse will be tolerated.
